# Alterations and additions, Erf lot 1167: 28 Balmoral Drive, Durban North, KwaZulu-Natal.

The case was tabled for a second time on 26 July 2023 for a decision by the Heritage Officers' Committee Meeting, who identified that although the building is more than 60 years at present, the additions and alterations were done before it turned 60 years of age. The building was categorised as being not conservation worthy.

# APPROVAL LETTER

We acknowledge receipt of your application for a permit to carry out work on the above property on the 19th of July 2023 The KZN Amafa and Research Institute (The Institute) reviewed the application on the 26th of July 2023.

# Please be advised as follows: -

- (1) Section 37(1) of the KZN Amafa and Research Institute Act (5/2018) requires that prior approval be obtained for work on buildings that are, or can reasonably be expected to be, over 60 years of age.
- (2) The work that was carried out without approval was carried out at a time when the building was not over 60 years of age. Therefore, no permit was required from the heritage authority at the time the work was carried out.
- (3) The building is now over 60 years of age and the formal approval from the heritage authority is required to comply with the provisions of the heritage legislation.
- (4) The proposed work did not impact on the heritage value or conservation worthiness of the property which the Institute has graded as (NCW Grade III....).
