Interim Comment

378 LANGALIBALELE STREET PIETERMARITZBURG KWAZULU-NATAL EXISTING BUILDINGS TO BE DEMOLISHED PROPOSED 2-STOREY BUILDING (SHOPS & OFFICES)

The application was discussed by the Heritage Officer's Committee on the 23rd of August 2023. Amongst other things, the following was discussed:

- It was noted that this site was within a highly sensitive section of Langalibalele Street and that the existing house had retained a significant amount of heritage features.
- The proposal did not fit in with the heritage streetscape.
- No elevations of the proposed replacement building were submitted.
- It was noted that the building appeared to have undergone some alteration in recent times but that no permit application had been submitted to Amafa.

FURTHER REQUIREMENT

The applicant was required to submit previous approved drawings that match what is existing or a Form I application was required to rectify the failure to obtain prior approval for the changes that are visible from the photos submitted.
