SAHRA Comments required on HIA Report for the Vaalbult Mining Project (Vaalbult 3IT), West of Carolina in Mpumalanga

As requested in a final comment from 13 February 2014, Palaeontological Monitoring has been conducted every six months and reports thereof have been submitted:

Millsteed, B. February 2016. Palaeontological Monitoring Report on the Colliery Pit an Waste Rock Stockpiles (Vaalbult Colliery) located on the Farm Vaalbult 31t, Mpumalanga Province.

Millsteed, B. August 2016. Palaeontological Monitoring Report (July 2016) On Vaalbult Colliery Pit located on the Farm Vaalbult 31t, Mpumalanga Province.

The author identified plant macrofossils as well as a trace fossil assemblages within the sedimentary strata that comprise the Vaalbult Colliery highwalls exposed in cuts 7, 36 and 62. The identified fossils are not of sufficient palaeontological significance but this may not always be the case.

The author's recommendations are:

- A member of staff (e.g., the Environment Officer) of the Vaalbult Mining Company (Pty) Ltd be trained to recognise the types of fossils that may be exposed via the mining operations. This officer should:
- o Make regular inspections of newly exposed rock material following blasting to identify if scientifically significant fossils have been exposed;
- o If significant fossils are present, they should be collected and placed in a safe, protected area for storage;
- o While the fossils are collected, precise notes of the location they were collected from must be collected, as

well as the lithological unit containing the fossils.

- An experience Karoo palaeobotanist should be mandated by the colliery to inspect the fossils, ascertain their significance and to make any necessary recommendations concerning their preservation.
- Due to the low abundance and low scientific importance of the fossil assemblages identified within the
 mine excavations to date it is recommended that the examinations of the colliery cuts by an experience
 Karoo palaeobotanist should continue, but that the frequency of those inspections be decreased from
 six monthly to 12 monthly (subject to later review).

Letter

The SAHRA Archaeology, Palaeontology and Meteorites (APM) Unit has reviewed the Palaeontological Monitoring Reports and agrees with the author's recommendations. Monitoring may from this date occur every 12 months instead of every 6 months.
