## Alterations and additions to existing buildings at 63 Florida Road, Rem of erf 630, Durban, Ethekwini, KwaZulu-Natal Drawing No. 63Florida 1/2 and 2/2

- The application received on 13 January 2023 and was reviewed by the Heritage Officers Committee on the 1st of February 2023. Amongst other things the following was discussed:
- It was noted that church had heritage value and was next door to and opposite heritage resources listed in the heritage register.
- The opening up of the side walls would destroy the main features of the church.
