The proposed project entails prospection on portion 9 (of 6) of the farm Mimosa Glen 855, Mangaung Metropolitan Municipality, located 10 km northeast from Bloemfontein, Free State Province. Proposed activities include vegetation clearing; excavation; stockpiling of topsoil, product and overburden; loading, hauling and transport; occasional blasting; and rehabilitation activities.
