# The existing WWTW is located on Portion 0 of the farm Greater Giyani No. 891 near the town of Giyani, which is part of the Greater Giyani Local Municipality within the Mopani District Municipality, in Limpopo Province.

PGS Heritage have been contracted to conduct the Heritage Impact Assessment (HIA) on behalf of EIMS (Environmental Impact Management Services) for Lepelle Northern Water (mandated by the Department of Water works) for the proposed expansion of the Giyani Wastewater Treatment Works.

The Giyani Wastewater Treatment Works facility is located on portion 0 of the Greater Giyani Farm No.891, just to the east of the Klein-Lataba River (Greater Giyani Local Municipality, Mopani District Municipality, Limpopo Province).

## Duriex, 2016. Mopani District Water and Wastewater Revitalisation Programme – Refurbishment and Upgrade of the Giyani Wastewater Treatment Works. Environmental Management Programme.

The proposed expansion will cover a total area of approximately 2ha (inclusive of the current facility boundaries). The proposed development includes the following upgrades and refurbishments of the existing facility: Existing works will be demolished to make way for the 14Ml facility (Upgraded from the existing 7Ml); two equal activated sludge reactors (7Ml each); new inlet works to projected inflow; conversion of existing facultative ponds into emergency overflow dams and upgrade of existing chlorination system.

### Fourie 2016, Proposed Upgrade of the Giyani Wastewater Treatment Works, Giyani, Limpopo Province. Heritage Impact Assessment.

There were no archaeological resources identified within the proposed development footprint. The area is underlain by Archaean rocks of the Giyani group, which are not know to be fossiliferous. It was recommended that the development may proceed.
