We will sample and date with C14 dating two specimens of mollusk that were pasted to the side of the some exposed MSA roof fall at PP5-6. Based on some prior C14 ages at PP5-6 South, we suspect that these may be remnants of a once complete cover of Holocene shell midden that was, perhaps in historic times, stripped away by local people for the purpose of lime production. If this is true then we need to know this, since that would have been a significant destructive process in the formation of the caves.
