

FFS TT Tank Storage Facility Expansion

Response to NID (Notification of Intent to Develop)

IN TERMS OF SECTION 38(8) OF THE NATIONAL HERITAGE RESOURCES ACT (ACT 25 OF 1999) AND SECTION 41(8) OF THE KWAZULU-NATAL AMAFA AND RESEARCH INSTITUTE ACT (ACT 05 OF 2018)

Attention: FFS Tank Terminals (Pty) Ltd

The FFS TT Phase II involves the expansion of the existing tank farm to include the following tanks: 3 x 3 212 m³ (Bitumen/Heavy Fuel Oil(HFO)), 2 x 1 634 m³ (Bitumen/Base oil/Veg Oil/Biodiesel/Slack wax), 3 x 2 655 m³ (HFO/Bitumen/Base Oil/Veg Oil/Biodiesel/Slack wax), 1 x 7 603 m³ (HFO/Base Oil/Veg Oil), 1 x 80 m³ (Industrial paraffin). Additional infrastructure is also required i.e., two aboveground pipelines

The application was considered by the Provincial Heritage Authority, the KwaZulu-Natal Amafa and Research Institute on 30 August 2023. The documents submitted in support of the application were reviewed including the detailed drawings and proposed activities for the FFS TT Phase II involving the expansion of the existing tank farm to include the following tanks: 3 x 3 212 m³ (Bitumen/Heavy Fuel Oil(HFO)), 2 x 1 634 m³ (Bitumen/Base oil/Veg Oil/Biodiesel/Slack wax), 3 x 2 655 m³ (HFO/Bitumen/Base Oil/Veg Oil/Biodiesel/Slack wax), 1 x 7 603 m³ (HFO/Base Oil/Veg Oil), 1 x 80 m³ (Industrial paraffin).

The conclusion that no heritage resources will be impacted by the proposed development has been accepted by the committee, and as a result, Amafa has no objection to the development provided that the developer operates within the confines of the recommendations provided in the reports and the records of this decision.

The developer is also required to adhere to the standard conditions and mitigation measures detailed below:

The developer is also required to adhere to the standard conditions detailed below:

Standard Conditions:

1. The KwaZulu-Natal Amafa and Research Institute should be contacted if any heritage objects are identified during earth-moving activities and all development should cease until further notice.
2. A Chance Finds Procedure must be followed should there be any fossils or graves discovered.

3. No structures older than sixty years or parts thereof are allowed to be demolished, altered, or extended without a permit from the KwaZulu-Natal Amafa and Research Institute.
4. Under no circumstances may any heritage material be destroyed, inundated, collected, or removed from the site unless under the direction of the KwaZulu-Natal and Amafa Research Institute and a heritage specialist.
5. Should any remains, that could potentially be human remains be found on-site, the South African Police Service (SAPS) should be contacted, and the KwaZulu-Natal Amafa and Research Institute must be notified immediately.
6. No SAPS official may disturb or exhume such remains, without the necessary permission from the KwaZulu-Natal Amafa and Research Institute.
7. No activities are allowed within 50m of a site that contains rock art.
8. Sources of all-natural materials (including topsoil, sands, natural gravels, crushed stone, asphalt, etc.) must be obtained in a sustainable manner and in compliance with the heritage and environmental (NEMA) legislation.
9. **Failure to comply with the requirements of the National Heritage Resources Act and the KwaZulu-Natal Amafa and Research Institute Act could lead to legal action being constituted against the applicant.**
