Amend The Registered Mining Area Of The Existing Mining Right For The Ballito Crushers (Pty) Ltd Dolerite Quarry On Portion 28 Of The Farm Lower Oaklands No. 16728 Near Shakaskraal, In The Stanger Magisterial District, KwaZulu-Natal Province.

Thank you for the opportunity to comment on this application that is basically an extension of the quarry onto land adjacent to the southern boundary of the approved Mining Area on the same property, Portion 28 of the farm Lower Oaklands No. 16728. The extension is by an additional 4 ha .The 2008 eThembeni report that you submitted was conducted on the development footprint and it it is an old HIA. At the time of the survey vegetation compromised visibility on sections of property. In addition the fossil sensitivity map shows that sections of the proposed area of development have a very high fossil sensitivity and will require a field-based assessment which includes a protocol for finds.

For this reason a Heritage Impact Assessment is required to establish if there are no heritage resources on the proposed extension with a view to offering suitable recommendations mitigation procedures. The assessment should cover the age of the buildings on the property.

The Study should cover:

- Identification of all heritage resources in the development area and its surroundings -50m
- · Assessment of the impact of the development on such heritage
- Evaluation of the impact of the development on heritage resources relative to the sustainable social and economic benefits to be derived from the development
- Results of consultation with communities affected by the proposed development and other interested and affected parties regarding the impact of the development on heritage resources.
- Consideration of alternatives if heritage resources are affected by the development
- Mitigation plans for any adverse effects during and after completion of the project
- Table of all heritage resources identified .This should show Heritage resource type, description, location, significance and reasons for this rating.
