Construction of a 132kV power line stretching from Eskom Holdings Ltd Theunispan substation located on the farm Vangpan 294 LQ to Ledjadja Coal (Pty) Ltd Boikarabelo Coal Mine (Kalkpan 243 LQ/Kruishout 271 LQ).

A 132Kv power line is proposed for the Boikarabelo Coal Mine. According to the information provided to SAHRA APM Unit the power line route will follow the alignment of the Boikarabelo rail way line and link and the Marapong-Boikarabelo effluent transfer pipeline. Since SAHRA APM Unit commented on the Boikarabelo railway project and Boikarabelo - Marapong effluent transfer pipeline, it is satisfied that the area has been extensively surveyed and a new heritage assessment will not be necessary in this instance. However, this is on condition that SAHRA recommendations contained within the review comments for the Boikarabelo railway project (dated 22 February 2012) and Marapong Boikarabelo Effluent Transfer (dated 11 October 2012) must be adhered to.
