Prospecting operation for diamonds on Portions 5, 16, 22, 23 and 49, Remainders of Portions 12, 19, 21 and 36 of the farm Rooidraai 85 IQ situated in the magisterial district of IQ (Ventersdorp), North West Province.

Lindie Wiehahn Consulting has been appointed by Ntswapedi Energy and Projects (Pty) Ltd to conduct a Basic Assessment Process in support of an Environmental Authorisation (EA) Application for proposed prospecting activities on Portions 5, 16, 22, 23 and 49, Remainders of Portions 12, 19, 21 and 36 of the farm Rooidraai 85 IQ situated in the Magisterial District of Ventersdorp, North West Province. A Basic Assessment Report (BAR) has been submitted in terms of the National Environmental Management Act, 1998 (NEMA) and the Environmental Impact Assessment (EIA) Regulations 2014 for activities that trigger the Mineral and Petroleum Resources Development Act, 2002 (MPRDA)(As amended). Prospecting activities will include drilling of nine boreholes, which when rehabbed will be covered by a cement slab of 1 m x 1 m x 0.5 m. Supporting infrastructure will include an ablution facility and access roads.

The BAR notes that a Heritage Assessment will be completed; however, no assessment has been submitted for review.
