## Interim Comment

### In terms of Section 38 of the National Heritage Resources Act (Act 25 of 1999)

**Terramanzi Group has been contracted to undertake an Environmental Permitting Process for a “new” access route to the Copperton Wind Farm. The current access route is not feasible as it runs through the Town of Copperton.**

Terramanzi Group has been appointed to conduct an Environmental Authorisation process for a new access road to the Copperton Wind Farm, near Copperton, Northern Cape Province. The access road will follow an existing farm road. Cedar Tower Services was appointed to conduct a Heritage Screener for the project.

The Heritage Screener noted that several previous Heritage Impact Assessments were conducted in the surrounding project area. Previously identified sites will not be impacted by the proposed road upgrade. A previous Palaeontological Impact Assessment found no significant fossils within the area and recommended that no further palaeontological assessments are required.
