Water Cube Services (Pty) Ltd were appointed by the Madibeng Local Municipality to undertake an application for Environmental Authorisation in the form of a Scoping and Environmental Impact Assessment (EIA) process for the proposed low-cost housing development on the Remaining Extent of the farm Tyne 250 JQ south-west of Brits, North West Province. A Draft EIA has been submitted in terms of the National Environmental Management Act, 1998 (Act 107 of 1998) (NEMA) and the 2014 NEMA EIA Regulations. The proposed low-cost housing development will consist of the establishment of housing units, bulk services, and social and economical activities over 65 ha.
