The proposed Zandriviers Drift (ZRD) limestone open cast mining project will be located on the farm Zandriviers Drift 188, Toekoms 974, Klein Moorland 973 and farm Vogelstruispan 189, situated within the greater Assen area, North West Province. PPC Currently operates an opencast limestone mine and associated crushing plant facility under an existing mining right at the Beestekraal mine. The existing Beestekraal operation is located near the town of Assen (approximately 52 km north of Brits) constituting a small farming community. The study area is situated in the Madibeng Local Municipality and furthermore forms part of the Bojanala District Municipality (BDM) of the North West Province.
