**Linked to enhancing its operations within South Africa, the 100 MW Solar PV facility (i.e. Skeerhok PV 2) proposed by juwi will cover an approximate area of 300 hectares (ha). The farm is a total of approximately 2157 ha. Due to the fact that this project only requires 300 ha of land, there is scope to avoid major environmental constraints through the final design of the facility within the development footprint. Thank you for notifying SAHRA that the Environmental Authorisation for the 100MW Skeerhok 2 PV Solar Facility on portion 9 of the farm Gemsbok Bult 120, near Kenhardt, Northern Cape Province (DEA Ref: 14/12/16/3/3/2/1034).

It is noted that the conditions contained within the Final Comment issued by SAHRA on the 16/03/2018 have not been included in the EA. These conditions include a 30 m buffer around site GBB2017/011. The applicant is reminded that no person may damage, destroy, disturb etc. any archaeological site without a permit as per section 35 of the National Heritage Resources Act, Act 25 of 1999 (NHRA). Additionally, SAHRA awaits the Final Environmental Impact Assessment (EIA), walk-down of the final layout, and Heritage Management Plan (HMP).
