Phase 1 Archaeological and Heritage Impact Assessment on the farms Barclay Vale 288 JT and Montrose 290 JT in respect of proposed agricultural development, Mpumalanga Province.

Hotazhel Developments NO1 (Pty) Ltd has appointed Henwood Environmental Solutions (Pty) Ltd to undertake a Basic Assessment process for the clearing of 6.07 ha of natural vegetation to make way for the Macadamia Orchards. The proposed farm is located on Barclay Vale 288 JT, in Mbombela Local Municipality of Mpumalanga Province. The Draft Basic Assessment Report is in support of an Environmental Authorisation Process in terms of the National Environmental Management Act, 107 of 1998, as amended (NEMA) for listed activities in the NEMA Environmental Impact Assessment (EIA) Regulations, 2014 as amended. A Heritage Impact Assessment (HIA) and Palaeontological Impact Assessment report have been submitted to SAHRA, in terms of section 38 (8) of the National Heritage Resources Act, 25 of 1999 (NHRA).

Celliers, J.P. Phase 1 Archaeological and Heritage Impact Assessment on the farms Barclay Vale 288 JT and Montrose 290 JT in respect of proposed agricultural development, Mpumalanga Province.

The author undertook a field assessment of the bush clearance area and identified 9 heritage sites within the farm of Barclay Vale 290 JT and 3 sites on the farm Montrose 288 JT. This comment will discuss the sites located on Barclay 290 JT, as the BAR assesses the environmental impacts on that farm only. However, all the sites apart from site BV8 are located outside the development footprint. Site BV8 is a concrete water reservoir that is of low significance. The site will be directly impacted by the proposed development and its sufficiently recorded in the report. Site BV9 is a formal cemetery located outside the development area, it's of high significance but it will not be impacted. The author recommends that the site is fenced with a gate to allow access to visiting family members.

currently untransformed areas on the Farms Montrose 290 JT and Barclay Vale 288 JT, Mpumalanga Province.

The author undertook a desktop study of the proposed development area and found that the area is underlain by basalts of the Hekpoort Formation (Pretoria Group), granites of the Nelspruit Batholiths (Nelspruit Suite) and cherts and dolomites of the Malmani Subgroup (Chuniespoort Group). The Nelspruit Batholith rocks are igneous and have no palaeontological significance, but rocks of the Malmani Subgroup have medium palaeontological significance. However, no algae fossils have been reported in the Nelspruit region.

SAHRA Archaeology, Palaeontology and Meteorites (APM) Unit agrees with the recommendations provided within the HIA and PIA reports, the following conditions must be included in the EMPr for implementation:

The Burial Grounds and Graves (BGG) Unit accepts the recommendations for the burial grounds identified in the HIA report and further recommends that Site BV9 must be fenced with an access gate, before fencing may occur permission from the family members must be sort. This must be done by undertaking a social consultation process to identify the family members of the site. This must be done in terms of Chapter IX of the NHRA Regulations and section 36(3) of the NHRA.

In the unlikely event that fossils are uncovered during construction then construction must cease within the immediate vicinity, a buffer of 30 m must be established, and a palaeontologist called in to inspect the finds. The palaeontologist must obtain a section 35(4) permit in terms of NHRA and Chapter IV NHRA Regulations, before any fossils are collected.

If there are any new heritages resources are discovered during construction and operation phases of the proposed development, then a professional archaeologist or palaeontologist, depending on the nature of the finds, must be contracted as soon as possible to inspect the findings at the expense of the developer.

If the newly discovered heritage resources prove to be of archaeological or palaeontological significance, a Phase 2 rescue operation may be required at the expense of the developer. Mitigation will only be carried out after the archaeologist or palaeontologist obtains a permit in terms of section 35 of the NHRA (Act 25 of 1999).
