SAHRA Archaeology, Palaeontology, Meteorites (APM) Unit cannot accept this HIA because the report does not contain a tracklog, as evidence of a field survey that was undertaken. In addition, the HIA does not contain a project description and it does not provide a map of the finalised plans of the residential development. Therefore, it is not clear if the impact area was assessed. The HIA does not follow the SAHRA 2007 minimum standards for impact assessment guidelines and section 38(3) of the NHRA.

It is not clear at which stage of the EA application process this application is in, this must be stated. If the comments were sourced from SAHRA after the EA was granted then this case must be made into a 38(1) application for SAHRA decision.

The HIA must be amended to address the above mentioned concerns and the amended HIA must be submitted to the case for commenting.
