Thank you for notifying SAHRA of the Environmental Authorisation (EA) and Mining Permit Application on the portion of the farm Portion 10 of Dorstfontein, Magisterial district of Kimberley, Northern Cape.

As the proposed development is undergoing an EA Application process in terms of the National Environmental Management Act, 107 of 1998 (NEMA), NEMA Environmental Impact Assessment (EIA) Regulations for activities that trigger the Mineral and Petroleum Resources Development Act, No 28 of 2002 (MPRDA)(As amended), it is incumbent on the developer to ensure that a **Heritage Impact Assessment** (HIA) is done as per section 38(3) and 38(8) of the National Heritage Resources Act, Act 25 of 1999 (NHRA). This must include an archaeological component, palaeontological component and any other applicable heritage components. The HIA must be conducted **as part of the** EA Application in terms of NEMA and the NEMA EIA Regulations.

It is noted that no HIA compiled in terms of section 38(3) has been submitted as part of the draft BAR. As per section 24(4)b(iii) of the NEMA, all impacts to heritage resources must be assessed with regards to every EA application process.

The quickest process to follow for the archaeological component would be to contract a specialist (see <u>www.asapa.org.za</u> or <u>www.aphp.org.za</u> to provide an Archaeological Impact Assessment (AIA). The AIA must comply with the SAHRA 2007 Minimum Standards: Archaeological and Palaeontological Component of Impact Assessments.

The proposed prospecting area is located within an area of high sensitivity in terms of palaeontological resources. An assessment of the impact of the development on palaeontological resources is required to be completed by a qualified palaeontologist. The report must comply with the SAHRA 2012 Minimum Standards:
