Lindie Wiehahn Consulting has been appointed by Tsediso Petrus Ramodise to conduct an Environmental Authorisation (EA) Application and Mining Permit Application for proposed prospecting on a portion of the farm Longlands 231, District of Barkley West, Northern Cape Province.

A Basic Assessment Report (BAR) has been submitted in terms of the National Environmental Management Act, no 107 of 1998 (NEMA), NEMA Environmental Impact Assessment (EIA) Regulations for activities that trigger the Mineral and Petroleum Resources Development Act, No 28 of 2002 (MPRDA)(As amended). The proposed mining activities will include an operations area of ±0.5731 ha that will consist of the plant, storage, road, dump and initial mining operations.

The BAR notes that no heritage resources will be impacted, however no HIA that complies with section 38(3) of the NHRA has been submitted.
