Environmental Impact Management Services (Pty) Ltd (EIMS) has been appointed by Koplan Intuthuko Planning & Development (KIPD) on behalf of the Thaba Chweu Municipality to assist in preparing and submitting the Scoping and Environmental Impact Assessment (EIA) Reports, a Water Use Licence Application (WULA) as well as undertaking a Public Participation Process (PPP), to obtain an Environmental Authorisation for the proposed Mashishing Township Establishment.

The extent of the township will be 231.3 ha constructed in two phases (Phase A: 77.9 ha and Phase B 151 ha) and mostly zoned for residential zoning 1 with zoning for cemeteries, schools, business areas, municipal areas and public open spaces. Construction will include a temporary construction camp, laydown areas, site clearance and service infrastructure.

Environmental Impact Management Service (Pty) Ltd have been appointed by Koplan Intuthuko Planning and Development (Pty) Ltd to undertake the Environmental Impact Assessment process in respect of listed activities in the Environmental Impact Assessment (EIA) Regulations 2017 as amended, that require an application for Environmental Authorisation in terms of the National Environmental Management Act, 1998 (NEMA), and a Water Use License in terms of the Water Use Licence Regulations, March 2017 in terms of the National Water Act, 36 of 1998.

To meet the requirements of section 38(8) of the National Heritage Resources Act, no 25 of 1999, a Heritage Scoping Report by PGS Heritage has been submitted to South African Heritage Resources Agency (SAHRA) for commenting.
