The property is located 5 km outside of Kimberley and is situated between the N12 south and Landbou road to the south of Kimberley, Northern Cape, South Africa.

Wadala Mining and Consulting (Pty) Ltd has been appointed by Henley Booysen to conduct an Environmental Authorisation (EA) and Mining Permit (MP) Application on a portion of the farm Eureka 200 near Kimberley, Northern Cape Province (NC30/5/1/3/2/10686MP).

A Basic Assessment Report (BAR) has been submitted in terms of the National Environmental Management Act, 107 of 1998 (NEMA), NEMA Environmental Impact Assessment (EIA) Regulations for activities that trigger the Mineral and Petroleum Resources Development Act, No 28 of 2002 (MPRDA)(As amended).
