Final Decision

In terms of Section 38(2) of the National Heritage Resources Act (Act 25 of 1999)

Eskom Dx, Mpumalanga operating unit is proposing to build 309m 22kV powerline to supply the St Josheph's Catholic Mission at Bongani area near Hazyview. The project will be within the farm Whitewaters 7 JU at Ehlanzeni District and Mbombela Municipality, Mpumalanga province. 14 m wooden poles will be used. The area of the holes will be 2X2m and 2.4 m deep.

Eskom SOC Ltd, Mpumalanga Operating Unit (MOU) is requesting on behalf of their applicant, that SAHRA grant them an exemption from conducting heritage studies for this proposed power line development. According to the documents submitted to the case, the proposed power line will be starting at the Burgershall 11 kV feeder to supply electricity to the St. Josephs Catholic Mission School. The power line is located close to the Crocodile river, along a gravel road servitude, and in between houses.

The photos provided in the application do not show any surface heritage features therefore, the potential impact on heritage resources is considered low. The construction of a 11 kV power line that is less than a kilometre in length will not change the character of the landscape. The likelihood of heritage artefacts being uncovered from the foundation excavations is low.

Final Decision

SAHRA Archaeology, Palaeontology and Meteorites (APM) Unit accepts Eskom Holdings (SOC) Ltd LOU's request for an exemption from further heritage assessments, for this proposed power line route. Therefore, in terms of section 38(2)*b* of the National Heritage Resources Act, no 25 of 1999 (NHRA) the proposed development is granted an exemption from undertaking a Heritage Impact Assessment.

SAHRA has no objections to this proposed development going ahead and this Final Decision applies to the provisions of the NHRA only.
