# **Final Decision**

## In terms of Section 38(2) of the National Heritage Resources Act (Act 25 of 1999)

Attention: Galaletsang Motlalekgosi Eskom-MOU

Eskom Distribution Mpumalanga Operating Unit(MOU) is proposing to electrify Technical village households near Acornhoek. The proposed MV powerline will be approx. 978m from the Rooiboklagte 22kV feeder and LV of approx. 1887m The project will be located on the farm Acornhoek 212 KU, Ehlanzeni Distric municipality, Bushbuckridge Municipality, Mpumalanga province. 2.4 m deep holes with the area of 2X2m will be dug to plant 14 m wooden poles. 32kVA and 100kVA transformers will be installed at poles ACRB34/9/4 and ACRB34/18 respectively

Eskom SOC Ltd, Limpopo Operating Unit (MOU) is requesting, on behalf of their applicant, that SAHRA grant them an exemption from conducting heritage studies for this proposed power line development. The power line will be supplying electricity to various households in the Technical Village next to Acornhoek, the power line will be constructed along existing gravel roads.

The photos provided to the case do not show any surface heritage features therefore, the potential impact on heritage resources is considered low. The construction of a 22 kV power line that is less than a kilometre in length will not change the character of the landscape. The likelihood of heritage artefacts being uncovered from the foundation excavations is low.

## **Final Decision**

SAHRA Archaeology, Palaeontology and Meteorites (APM) Unit accepts Eskom Holdings (SOC) Ltd MOU's request for an exemption from further heritage assessments, for this proposed power line route. Therefore, in terms of section 38(2)b of the National Heritage Resources Act, no 25 of 1999 (NHRA), the proposed development is granted an exemption from undertaking a Heritage Impact Assessment.

SAHRA has no objections to this proposed development going ahead and this Final Decision applies to the

The following conditions still apply and need to be added to Appendix C 1.22:

If there are any new heritage resources discovered during construction and operation phases of the proposed development, then a professional archaeologist or palaeontologist, depending on the nature of the finds, must be contracted as soon as possible to inspect the findings at the expense of the developer.

If the newly discovered heritage resources prove to be of archaeological or palaeontological significance, a Phase 2 rescue operation may be required at the expense of the developer. Mitigation will only be carried out after the archaeologist or palaeontologist obtains a permit in terms of section 35 of the NHRA (Act 25 of 1999). If any unmarked human burials are uncovered and the archaeologist called in to inspect the finds and/or the police find them to be heritage graves, then mitigation may be necessary and the SAHRA Burial Grounds and Graves (BGG) Unit must be contacted for processes to follow (Mimi Seetelo 072 802 1251).
