## Letter

### In terms of Section of the National Heritage Resources Act (Act 25 of 1999)

Attention: Eskom MOU

**Eskom Mpumalanga Operating Unit is proposing to construct a 22 Kv power line which is 2.8 km at Khumbula Village on the farm Kabokweni 148-JU within Enhlanzeni District, Mbombela Local Municipality, Mpumalanga Province. The project will entail digging 2x2m and 2.4 meters deep holes to plant 14m wooden poles. The proposed power line is for the Khumbula Village Electrification project.**

Eskom SOC Ltd, Mpumalanga Operating Unit (MOU) is requesting on behalf of their applicant, that SAHRA grant them an exemption from conducting heritage studies for this proposed power line development. According to the documents submitted to the case, the proposed new MV power line will be 2800 metres. The proposed new power line will be starting at JC 22 kV feeder, on the farm Kabokweni JU, in the Mbombela Local Municipality of Mpumalanga Province. The power line will be constructed along the road servitude.

SAHRA issued a NID requesting additional photographs of the proposed power line route in 19/09/2019 however, the same set of photos were re-submitted. Therefore, SAHRA cannot process this case without photos of each pole position for the entire route.

A survey diagram still has not been provided to the case. This must be provided and it must contain a legend to guide in the understanding of the various symbols on the map, and cross section of the pole and the depth of excavations.

### SAHRA Response to Notification of Development

This application constitutes a section 38 (1) application for approval by SAHRA in terms of the National Heritage Resources Act, no 25 of 1999 (NHRA), as the proposed power line exceeds 300 metres in length. As such SAHRA is providing response in terms of section 38(2) with regards to this application.

In order for SAHRA to process this case a detail project description of the Nature and extent of the development must be submitted.

SAHRA requires ground level photographic images of the power line route and photos of the pole positions on the ground to be uploaded to the case, along with a desd, a project description, depth of foundations required for the wooden pole.
