Construction of sports field irrigation and facilities infrastructure in Calvinia (Hantam Local Municipality) Northern Cape Province. The irrigation system infrastructure to allow for the required flow rate includes a 4.49km long rising main irrigation pipeline, which will be buried underground.

EnviroAfrica has been appointed by the Department of Agriculture, Land Reform and Rural Development to conduct an Environmental Authorisation (EA) Application for the proposed Calvinia Sportfield Irrigation Pipelines, Calvinia, Northern Cape Province.

A Basic Assessment Report (BAR) was followed in terms of the National Environmental Management Act, no 107 of 1998 (NEMA) and the NEMA Environmental Impact Assessment (EIA) Regulations. The Environmental Management Programme (EMPr) has been submitted to SAHRA. The proposed development will include the construction of a pump station, two 120kl reservoirs, pipelines and fencing.

Natura Viva CC and the Agency for Cultural Resource Management has been appointed to provide heritage specialist input as part of the EA process as required by section 24(4)b(iii) of NEMA and section 38(8) of the National Heritage Resources Act, Act 25 of 1999 (NHRA) that complies with section 38(3) of the NHRA.

Almond, J. E. 2019. Palaeontological Specialist Study: Letter of Exemption. Sportfield Irrigation Pipelines in Calvinia, Hantam Municipality, Namaqua District, Northern Cape Province.

The proposed development area is underlain by the Tierberg Formation of low palaeontological sensitivity that is known to contain fossils of fish teeth and scales, leaves, petrified wood and burrows. Due to the small size of the development footprint and the evidence of previous disturbances, the overall impact is considered to be very low. A Chance Fossil Finds Procedure is recommended to be followed and is provided in the report.
