Final Comment

In terms of Section 38(4), 38(8) of the National Heritage Resources Act (Act 25 of 1999)

Attention: McTaggarts PV2 (PTY) Ltd

Applicant: McTaggarts PV3 (PTY) Ltd The development of four (4) separate solar photovoltaic (PV) facilities, each with a contracted capacity of up to 75MW located ~20km south-west of Upington within the Upington Renewable Energy Development Zone (or REDZ 7). The projects are located in the Kai !Garib Local Municipality and within the ZF Mgcawu District Municipality in the Northern Cape. The Dawid Kruiper Local Municipality is located directly to the east.

Savannah Environmental (Pty) Ltd has been appointed by McTaggarts PV3 (Pty) Ltd to conduct an Environmental Authorisation (EA) Application for the proposed McTaggarts PV3 Solar PV Facility and associated infrastructure, near Upington, Northern Cape Province.

A Basic Assessment Report has been submitted in terms of the National Environmental Management Act, no 107 of 1998 (NEMA) and the NEMA Environmental Impact Assessment (EIA) Regulations. The proposed activities include the construction of PV panels, inverter stations, temporary laydown area, cabling between components, a 22kV or 33kV/132kV on-site substation, access road, internal access roads, and operation and maintenance buildings covering 260 ha. The proposed development is located within the Upington Renewable Energy Development Zone (REDZ).

Professor Marion Bamford and Cedar Tower Services (Pty) Ltd have been appointed to provide heritage specialist input as part of the BAR process as required by section 24(4)b(iii) of NEMA and section 38(3) and 38(8) of the National Heritage Resources Act, Act 25 of 1999 (NHRA).

Lavin, J. 2019. Heritage Impact Assessment in terms of section 38(8) of the NHRA for the Proposed development of McTaggarts PV3, a solar PV facility and associated infrastructure of portion 3 of the farm McTaggarts 453 and portion 22 of the farm Klip Punt 452 near Upington in the Northern Cape Province.

The report above used the results of the following two reports below to conduct the Heritage Impact Assessment. It must be noted that the reports assessed the grid connection and other parts of the Khunab project, which is not part of the current NEMA application. Only results pertaining to the PV 3 development will be discussed below.

Bamford, M. 2019. Palaeontological Impact Assessment for the proposed development of the Khunab Solar Development and Khunab Solar Grid Connection to the west of Upington, Northwest Province (sic).

The proposed McTaggarts PV 3 development area is underlain by alluvial and aeolian sediments of the Gordonia Formation. These sediments do not preserve fossils and no palaeo-pans or palaeo-channels have been recorded in the area. Impact to palaeontological resources would be very unlikely. A Chance Fossil Finds Procedure is recommended and provided in the report.

Lavin, J and Engelbrecht, J. 2019. Archaeological Specialist Study in terms of section 38(8) of the NHRA for a proposed development of the Khunab Solar Development and Khunab Solar Gird connection, Upington, in the Northern Cape Province.

One surface scatter of Stone Age lithics was identified of negligible cultural significance. No other heritage resources were identified within the proposed development area.

Recommendations provided in the report include the following:

- Although all possible care has been taken to identify sites of cultural importance during the
 investigation of the study area, it is always possible that hidden or subsurface sites could be
 overlooked during the assessment. If any evidence of archaeological sites or remains (e.g. remnants of
 stone-made structures, indigenous ceramics, bones, stone artefacts, ostrich eggshell fragments,
 charcoal and ash concentrations), fossils or other categories of heritage resources are found during the
 proposed development, SAHRA APM Unit (Natasha Higgitt/Phillip Hine 021 462 5402) must be alerted;
- If unmarked human burials are uncovered, the SAHRA Burial Grounds and Graves (BGG) Unit (Thingahangwi Tshivhase/Mimi Seetelo 012 320 8490), must be alerted immediately as per section 36(6) of the NHRA. A professional archaeologist must be contracted as soon as possible to inspect the findings. A Phase 2 rescue excavation operation may be required subject to permits issued by SAHRA.

- 38(4)c(i) If any evidence of archaeological sites or remains (e.g. remnants of stone-made structures, indigenous ceramics, bones, stone artefacts, ostrich eggshell fragments, charcoal and ash concentrations), fossils or other categories of heritage resources are found during the proposed development, SAHRA APM Unit (Natasha Higgitt/Phillip Hine 021 462 5402) must be alerted as per section 35(3) of the NHRA. Non-compliance with section of the NHRA is an offense in terms of section 51(1)e of the NHRA and item 5 of the Schedule;

If the newly discovered heritage resources prove to be of archaeological or palaeontological significance, a Phase 2 rescue operation may be required subject to permits issued by SAHRA;
- The Final BAR and EMPr must be submitted to SAHRA for record purposes;
- The decision regarding the EA Application must be communicated to SAHRA and uploaded to the SAHRIS Case application.
