Schoeman Broerdery is proposing to amend the existing power line route on Portion 11, remainder of Portion 12, and remainder of Portion 1 on the farm Blauwwildebeestfontein 16 JS near Polokwane in the Limpopo Province. The power line will be starting at the Marble Hall/Mosesrivier Overhead 22kV feeder. The new line will be 784 metres in length and then 801 metres of the old line will be dismantled.

The information provided in this case is insufficient to substantiate the motivation for SAHRA to grant an exemption from conducting a heritage assessment. The minimum required information should be the following:

Ground level photos of the proposed power line route including photos of each pole position,

A signed wayleave,

A project description provided to the case containing a description of the environment in which the power line will be constructed in.

The area is also located in a grey palaeo-sensitivity area and the power line will have negligible impact on the palaeo-heritage.
