Phase 1 Heritage Impact Assessment of the Proposed Development of a Township on the Remaining Extent of Portion 4 of Alldays 295 Ms within Blouberg Local Municipality of Capricorn District.

RR Cultural Resources Consultants cc have been appointed by Phakanani Environmental (Pty) Ltd to undertake a Heritage Impact Assessment (HIA) on behalf of their applicant who is proposing to develop a township on the remainder of Portion 4 of the Alldays 295 MS, in the Blouberg Local Municipality of the Limpopo Province.

To meet the requirements of the National Heritage Resources Act, Act 25 of 1999 (NHRA) a HIA report has been submitted to SAHRA for commenting.

Roodt, F. *Janury 2020. Phase 1 Heritage Impact Assessment of the Proposed Development of a township on the Remaining Extent of Portion 4 of The Alldays 295 MS within Blouberg Local Municipality of Capricorn District.*

The author undertook a field survey of the proposed development and did not identify any heritage resources located within the proposed development footprint. The report also contains a summary of the local geology however, there is no indication that a palaeontologist has reviewed this section.

The author provides no further recommendations.

A report of the desktop palaeontological assessment must adhere to the 2012 palaeontological minimum standards.
