Eskom SOC Ltd, Limpopo Operating Unit (LOU) is requesting on behalf of their applicant, that SAHRA grant them an exemption from conducting heritage studies for this proposed power line development. According to the documents submitted to the case, the proposed new power line will be 342.60 metres an additional 41.13 metres of power line will be restrung, and 320 metres will be dismantled. The power line will be starting at Toitskraal/Elandsdrift 11 kV feeder, located on Portion 125 of the farm Loskop North 12 JS, in the Limpopo Province.

The information provided in this case is insufficient to substantiate the motivation for SAHRA to grant an exemption from conducting a heritage assessment. The minimum required information should be the following:

- Ground level photos of the proposed power line route including photos of each pole position.
- A survey diagram provided with a legend to guide in the understanding of the various symbols on the map, and cross section of the pole and the depth of excavations.
- A project description provided to the case containing a description of the environment in which the power line will be constructed in.
- The proposed power line route is also located in a grey palaeo-sensitivity area which has a negligible sensitivity.

SAHRA Response to Notification of Development

This application constitutes a section 38 (1) application for approval by SAHRA in terms of the National Heritage Resources Act, no 25 of 1999 (NHRA), as the proposed power line exceeds 300 metres in length. As such SAHRA is providing response in terms of section 38(2) with regards to this application.
