## Final Decision

### In terms of Section 38(2) of the National Heritage Resources Act (Act 25 of 1999)

**Rural Maintenance (Pty) Ltd intends to construct the powerline for the above-mentioned project. The project includes dismantling of 821m of old powerline and new MV powerline of 40m which will be connected to the existing pole number TBW160/1 in the area (refer to the Span plan sheets and the Pegging Coordinates for more information) traversing Klipbokspruit 30LQ, in the Lephalele Local Municipality of the Limpopo Province.**

Rural Maintenance (Pty) Ltd is requesting, on behalf of their applicant, that SAHRA grant them an exemption from conducting heritage studies for this proposed power line development. According to the documents submitted to the case, the proposed new power line will be starting at the Woudend 22 kV feeder, the length of the new line will be 40m and another 821m will be dismantled. The proposed power line will be located on the remainder of the farm Klipbokspruit 30 LQ, in the Lephalele Local Municipality of Limpopo Province. The power line will be supplying electricity to a farm and it will be constructed along existing gravel roads.

The photos provided to the case do not show any surface heritage features therefore, the potential impact on heritage resources is considered low. The construction of a 11 kV power line that is less than a kilometre in length will not change the character of the landscape. The likelihood of heritage artefacts being uncovered from the foundation excavations is low. However, the area is relatively undisturbed, and any construction close to the dry stream bed must be monitored by the construction manager.

The area is also located in a green palaeo-sensitivity area, which indicates that the area has moderate sensitivity to occurrence of fossiliferous rocks. However, the power line will have negligible impact on the palaeo-heritage as such SAHRA grants this development an exemption from undertaking a palaeontological study.

SAHRA Archaeology, Palaeontology and Meteorites (APM) Unit accepts Rural Maintenance (Pty) Ltd's request for an exemption from further heritage assessments, for this proposed power line route. Therefore, in terms of section 38(2)b of the National Heritage Resources Act, no 25 of 1999 (NHRA), the proposed development is granted an exemption from undertaking a Heritage Impact Assessment.

SAHRA has no objections to this proposed development going ahead and this Final Decision applies to the provisions of the NHRA only.

The following conditions still apply and need to be added to Appendix C 1.22:

If there are any new heritage resources discovered during construction and operation phases of the proposed development, then a professional archaeologist or palaeontologist, depending on the nature of the finds, must be contracted as soon as possible to inspect the findings at the expense of the developer.

If the newly discovered heritage resources prove to be of archaeological or palaeontological significance, a Phase 2 rescue operation may be required at the expense of the developer. Mitigation will only be carried out after the archaeologist or palaeontologist obtains a permit in terms of section 35 of the NHRA (Act 25 of 1999). If any unmarked human burials are uncovered and the archaeologist called in to inspect the finds and/or the police find them to be heritage graves, then mitigation may be necessary and the SAHRA Burial Grounds and Graves (BGG) Unit must be contacted for processes to follow (Mimi Seetelo 072 802 1251).
