Eskom Holdings SOC Ltd, Limpopo Operating Unit (LOU) intends to construct the power line for the above-mentioned project. The power line will include new 312M MV which will T-off from the existing power line in pole number BBL258/75/19/10 (refer to the Span plan sheets and the Pegging Coordinates for more information) traversing on the of Farm The Bul-Bul 5-Ls in Blouberg Local Municipality of Capricorn District Municipality of the Limpopo Province

Eskom SOC Ltd, Limpopo Operating Unit (LOU) is requesting on behalf of their applicant, that SAHRA grant them an exemption from conducting heritage studies for this proposed power line development. According to the documents submitted to the case, the proposed new power line will be 312 metres starting at Blouberg 22 kV feeder, on the farm Bul-Bul 5 LS, in the Blouberg Local Municipality, of Limpopo Province. The power line will be supplying electricity to a rural village.

SAHRA issued a letter requesting that a new .kml file is submitted to the case and that the .kml file must be a simple file created on google earth using lines to demarcate the power line route. This file has since been submitted as requested.

The photos provided to the case do not show any surface heritage features therefore, the potential impact on heritage resources is considered low. The construction of a 22 kV power line that is less than a kilometre in length will not change the character of the landscape. The likelihood of heritage artefacts being uncovered from the foundation excavations is low. However, the area is relatively undisturbed, and any construction close to the dry stream bed must be monitored by the construction manager.

However, the proposed power line route is also located in a green palaeo-sensitivity area which would normally require a desktop assessment or letter of exemption from undertaking a a palaeontological assessment by a suitably qualified palaeontologist, but due to the power line being less than 1 km in length SAHRA grants the applicant exemption from undertaking this study.

SAHRA Archaeology, Palaeontology and Meteorites (APM) Unit accepts Eskom Holdings (SOC) Ltd LOU's request for an exemption from further heritage assessments, for this proposed power line route. Therefore, in terms of section 38(2)b of the National Heritage Resources Act, no 25 of 1999 (NHRA), the proposed development is granted an exemption from undertaking a Heritage Impact Assessment.

SAHRA has no objections to this proposed development going ahead and this Final Decision applies to the provisions of the NHRA only.

The following conditions still apply and need to be added to Appendix C 1.22:

If there are any new heritage resources discovered during construction and operation phases of the proposed development, then a professional archaeologist or palaeontologist, depending on the nature of the finds, must be contracted as soon as possible to inspect the findings at the expense of the developer.

If the newly discovered heritage resources prove to be of archaeological or palaeontological significance, a Phase 2 rescue operation may be required at the expense of the developer. Mitigation will only be carried out after the archaeologist or palaeontologist obtains a permit in terms of section 35 of the NHRA (Act 25 of 1999). If any unmarked human burials are uncovered and the archaeologist called in to inspect the finds and/or the police find them to be heritage graves, then mitigation may be necessary and the SAHRA Burial Grounds and Graves (BGG) Unit must be contacted for processes to follow (Mimi Seetelo 012 320 8490).
