Eskom Holdings SOC Ltd, Limpopo Operating Unit (LOU) intends to construct the power line for the above-mentioned project. The power line will include new 0.650KM MV which will T-off from the existing power line in pole number BAD153/19 (refer to the Span plan sheets and the Pegging Coordinates for more information) traversing on the of Farm Wilhanshohe No 78-Ls in Blouberg Local Municipality of Capricorn District Municipality of the Limpopo Province

Eskom SOC Ltd, Limpopo Operating Unit (LOU) is requesting on behalf of their applicant, that SAHRA grant them an exemption from conducting heritage studies for this proposed power line development. According to the documents submitted to the case, the proposed new power line will be 650 metres starting at Alpine Dam 22 kV feeder, on the farm Wilhanshohe 78 LT, in the Blouberg Local Municipality, of Limpopo Province. The power line will be supplying electricity to a rural village.

SAHRA Response to Notification of Development

This application constitutes a section 38 (1) application for approval by SAHRA in terms of the National Heritage Resources Act, no 25 of 1999 (NHRA), as the proposed power line exceeds 300 metres in length. As such SAHRA is providing response in terms of section 38(2) with regards to this application.

SAHRA Archaeology, Palaeontology and Meteorites Unit cannot make an informed decision on this proposed development because the .kml file submitted to the case does not contain any location information.

SAHRA requires a populated .kml file to be submitted to the case on SAHRIS before the case is processed further.
