### **Karroid PV**

Cape EAPrac has been appointed by Karroid PV (Pty) Ltd to conduct an Environmental Authorisation (EA) Application for the proposed Karroid PV on RE Farm Geel Kop Farm No. 456, near Upington, Northern Cape Province.

A draft Basic Assessment Report (dBAR) has been submitted in terms of the National Environmental Management Act, no 107 of 1998 (NEMA) and the NEMA Environmental Impact Assessment (EIA) Regulations. The proposed infrastructure will include solar panels, on-site substation, internal access roads, laydown area, auxiliary buildings, battery storage, inverter stations, electrified perimeter fencing and security infrastructure. The total extent of the development area will be 240 ha. The proposed development is located within Focus Area 7 of the Renewable Energy Development Zones i.e. the Upington REDZ.

The DBAR notes that the Public Review period is between 6 July 2020 to 6 August 2020. It must be noted that the SAHRIS case was created on the 18/07/2020, therefore in terms of NEMA EIA Regulations section 3, the SAHRA review period will end on the 18/08/2020.

Prof Marion Bamford and Heritage Contracts and Archaeological Consulting had been appointed to provide heritage specialist input as part of the BAR process as required by section 24(4)b(iii) of NEMA and section 38(3) and 38(8) of the National Heritage Resources Act, Act 25 of 1999 (NHRA).

Tertiary calcrete and sands that do not contain fossils but might cover fossils trapped in pans or springs. Gordonia Formation sands overly these rocks that may contain recent Quaternary fossils in pan or spring deposits. A Chance Fossil Finds Procedure is recommended and provided in the report.

A total of two heritage resources including a historical artefact scatter and an Early Stone Age site were identified. The ESA site was rated as a heritage resource of medium significance. Isolated surface scatters of Middle Stone Age and Later Stone Age lithics were also identified as noted in Table 8. The historical artefact scatter and isolated Stone Age scatters were rated as having a low significance rating.

The recommendations provided in the HIA include the following:

- Surface sampling and analysis of artefacts are recommended at Waypoint 113 (ESA Site) to ensure that the technology is adequately described;
- Development of a heritage management plan for the entire Geel Kop Farm RE456 prior to construction;
- Implementation of a chance find procedure for both the archaeological and palaeontological components.

## **Final Comment**

The following comments are made as a requirement in terms of section 3(4) of the NEMA Regulations and section 38(8) of the NHRA in the format provided in section 38(4) of the NHRA and must be included in the Final BAR and EMPr:

- 38(4)a The SAHRA Archaeology, Palaeontology and Meteorites (APM) Unit has no objections to the proposed development;
- 38(4)b The recommendations of the specialists are supported and must be adhered to. Further additional specific conditions are provided for the development as follows:
- A permit in terms of section 35 of the NHRA and Chapter II and IV of the NHRA regulations must be applied for if the EA is granted for the proposed development and before construction occurs, in order to collect a representative sample of Stone Age lithics from the affected area;
- The Heritage Management Plan must be submitted to SAHRA for comment prior to the construction

- 38(4)c(i) If any evidence of archaeological sites or remains (e.g. remnants of stone-made structures, indigenous ceramics, bones, stone artefacts, ostrich eggshell fragments, charcoal and ash concentrations), fossils or other categories of heritage resources are found during the proposed development, SAHRA APM Unit (Natasha Higgitt/Phillip Hine 021 462 5402) must be alerted as per section 35(3) of the NHRA. Non-compliance with section of the NHRA is an offense in terms of section 51(1)e of the NHRA and item 5 of the Schedule;
- 38(4)c(ii) If unmarked human burials are uncovered, the SAHRA Burial Grounds and Graves (BGG) Unit (Thingahangwi Tshivhase/Mimi Seetelo 012 320 8490), must be alerted immediately as per section 36(6) of the NHRA. Non-compliance with section of the NHRA is an offense in terms of section 51(1)e of the NHRA and item 5 of the Schedule;
- 38(4)d See section 51(1) of the NHRA;
- 38(4)e The following conditions apply with regards to the appointment of specialists:
- i) If heritage resources are uncovered during the course of the development, a professional archaeologist or palaeontologist, depending on the nature of the finds, must be contracted as soon as possible to inspect the heritage resource. If the newly discovered heritage resources prove to be of archaeological or palaeontological significance, a Phase 2 rescue operation may be required subject to permits issued by SAHRA;
- As the SAHRA case was only created on the 18/07/2020, in terms of Section 3 of the NEMA EIA
  regulations, SAHRA commenting period ends on the 18/08/2020. The Final BAR should not be
  submitted for decision making process to the competent authority without integrating SAHRA comment
  as per section 38(8) of the NHRA;
- The Final BAR and EMPr must be submitted to SAHRA for record purposes;
- The decision regarding the EA Application must be communicated to SAHRA and uploaded to the SAHRIS Case application.
