Eskom SOC Ltd, Limpopo Operating Unit (LOU) is requesting, on behalf of their applicant, that SAHRA grant them an exemption from conducting heritage studies for this proposed power line development. According to the documents submitted to the case, the proposed new power line will be starting at Bolebedu/Modjadji 22 kV feeder, and will be 435 m in length located on Unsurveyed stateland in the Musina Local Municipality of Limpopo Province. The power line will be supplying electricity to a borehole in the Tihabeleng rural village.

The information provided in this case is insufficient to substantiate the motivation for SAHRA to provide a letter, or decision. The minimum required information should be the following:

- Ground level photos of the proposed power line route including photos of each pole position.
- The .kml file of the proposed power line route submitted to the case does not provide a map of a power line route as it appears in the survey diagram. The .kml file must map the power line route using lines not a polygon.

SAHRA Response to Notification of Development

This application constitutes a section 38 (1) application for approval by SAHRA in terms of the National Heritage Resources Act, no 25 of 1999 (NHRA), as the proposed power line exceeds 300 metres in length. However, SAHRA cannot provide a response in terms of section 38(2) for this application until the aforementioned .kml file and ground level photographs are submitted to the case.

SAHRA will respond to the NID once this information is uploaded to the case.
