Eskom Holdings SOC Ltd, Limpopo Operating Unit (LOU) intends to construct the powerline for the above-mentioned project. The powerline will be connected from the existing powerline in the area from pole number MTK277/24,

Eskom SOC Ltd, Limpopo Operating Unit (LOU) is proposing to construct a new power line on behalf of their applicant in order to supply electricity to the applicants household in the Tsianda Village. According to the documents submitted to the case, the proposed new power line will be 1246 metres starting at Maludane/Tshakhuma 22 kV feeder, on the farm Reubainder 21 MT, in the Limpopo Province.

SAHRA issued a Notification of Intent to Develop (NID) letter requesting a .kml file that maps the power line route as it appears on the span plan document, and a letter of exemption from undertaking a palaeontological assessment by a suitably qualified palaeontologist to determine whether the power line will not have an impact on palaeo-heritage.

Bamford, M. November 2020. Palaeontological Impact Assessment for the Proposed Tsianda Electrification Project, Makhado Local Municipality, Limpopo Province.

The study area is underlain by basalts of the Sibasa Formation, Soutpansberg Group, which has no palaeontological significance. The proposed new power line will have no impact and recommends no further mitigation measures.
