Nkomazi Game Reserve is proposing to construct a 800 meter, 22kV Eskom overhead power line to supply electricity to the tented camp.

Eskom SOC Ltd, Mpumalanga Operating Unit (MOU) is proposing to construct a new power line on behalf of their applicant, Nkomazi Game Reserve, located near the town of eManzana and Tjakastad. According to the documents submitted to the case, the proposed new power line will be 505m in length, starting at Moletsi/Koloni 22 kV feeder, on the remainder of the farm Boekenhoutstrand 722 JT, in the Albert Luthuli Local Municipality of Mpumalanga Province.

Nkomazi Game Reserve appointed Core Environmental (Pty) Ltd, who in turn appointed Adonsonia Heritage Consultants cc to undertake a Heritage Impact Assessment (HIA) in terms of section 38(1) of the National Heritage Resources Act, Act 25 of 1999, (NHRA).

Van Wyk Rowe, C. A Phase 1 Archaeological and Heritage Impact Assessment: Proposed 1km ESKOM POWERLINE on the farm Boekenhoutsrand 722JT on the Nkomazi Game Reserve, near Tjakastad, Mpumalanga Province.

The author undertook a field assessment of the proposed power line route within the Nkomazi Game Reserve and did not identify any heritage resources there. The study area is known to contain some significant heritage resources and a stone walled settlement is located within the reserve. However, it is not near the power line servitude.
