# Proposed Sandveld 22 kV powerline upgrade. The powerline is 15 306 m in length, in Hopetown, Thembelihle local municipality.

Eskom has submitted an application in terms of section 38(1) of the National Heritage Resources Act, Act 25 of 1999 (NHRA) for a proposed 22kv powerline to be constructed on the farm Jolmans Dam 51, near Hopetown, Northern Cape Province.

The proposed powerline will be 15.306 km long and constructed from 11 m wooden poles, adjacent to an existing powerline.

The proposed development is located in an area of moderate and high palaeontological sensitivity as per the SAHRIS PalaeoSensitivity map. The proposed line route is to be located within mostly undisturbed terrain.

In a comment issued on the 04/02/2021, SAHRA requested that an assessment of archaeological and palaeontological resources be conducted for the proposed development. Since the issuing of the comment, a PIA and HIA have been submitted fore review (24/11/2021).

Marion, Bamford. 2021. Palaeontological Impact Assessment for the proposed Sandveld 22 kV power line, Thembelihle Local Municipality, near Hopetown, Northern Cape Province.

The proposed development is underlain by ancient and non-fossiliferous geology of the Ventersdorp Supergroup which are overlain by Tertiary Calcrete and Quaternary aeolian sands that may contain fossils, however, no palaeo-spring and palaeo-pan sites were visible from the satellite imagery. A Fossil Chance Finds Protocol should be included in the EMPr.

Van der Walt, J. 2021. Heritage Impact Assessment for the proposed Sandveld 22kV powerline upgrade near Hopetown, Northern Cape Province.

A total of four heritage resources were identified along the proposed powerline route. These include two isolated low density Middle Stone Age lithic surface scatters of low heritage significance and two higher density Middle and Later Stone Age lithics scatters (Sand 01 and Sand 02) of medium heritage significance.

Recommendations provided in the report include the following:

- Implementation of a chance find procedure for the project;
- A buffer area of 15 meters around Sand 01 must be indicated on development maps and avoided during construction.

#### **Final Decision**

The following comments are made as a requirement in terms of section 38(2) and 38(4) of the NHRA and must be adhered to:

- 38(4)a The SAHRA Archaeology, Palaeontology and Meteorites (APM) Unit has no objections to the proposed development;
- 38(4)b If Sand 01 cannot be avoided with the recommended 15 m buffer zone, a permit in terms of section 35(4) of the NHRA must be applied for from SAHRA. No construction activities may commence without a permit issued by SAHRA in this regard;
- 38(4)c(i) If any evidence of archaeological sites or remains (e.g. remnants of stone-made structures, indigenous ceramics, bones, stone artefacts, ostrich eggshell fragments, charcoal and ash concentrations), fossils or other categories of heritage resources are found during the proposed development, SAHRA APM Unit (Natasha Higgitt/Phillip Hine 021 462 5402) must be alerted as per section 35(3) of the NHRA. Non-compliance with section of the NHRA is an offense in terms of section 51(1)e of the NHRA and item 5 of the Schedule;
- 38(4)c(ii) If unmarked human burials are uncovered, the SAHRA Burial Grounds and Graves (BGG) Unit (Thingahangwi Tshivhase/Mimi Seetelo 012 320 8490), must be alerted immediately as per section 36(6) of the NHRA. Non-compliance with section of the NHRA is an offense in terms of section 51(1)e of the NHRA and item 5 of the Schedule;
- 38(4)d See section 51(1) of the NHRA;
- 38(4)e The following conditions apply with regards to the appointment of specialists:
