Final Decision

In terms of Section 38(2) of the National Heritage Resources Act (Act 25 of 1999)

Eskom Holdings SOC Ltd, Limpopo Operating Unit (LOU) hereby notifying you that it intends to electrify the village of Keletse Ke Mme. The power line will include a new LV for a length of 1867.24m and MV line for 166.78m which will be connected from the existing power line on pole VNB 360/14/20/14/1 at Keletse Ke Mme Village. Refer to the Span plan sheets and the Pegging Coordinates for more information) traversing in the remainder of the farm Portion 1 Melinda 164LR in the Lephalale Municipality of Waterberg District Municipality of Limpopo Province.

Eskom SOC Ltd, Limpopo Operating Unit (LOU) is proposing to construct a new power line on behalf of their applicant, to supplying electricity to various households in the Keletse ke Mme. According to the documents submitted to the case, the proposed new power line will be starting at Villa Nera/Beauty 22 kV feeder constructed along existing gravel road servitudes.

The photos provided to the case do not show any surface heritage features therefore, the potential impact on heritage resources is considered low. The construction of a 22 kV power line within a village will not change the character of the landscape. The likelihood of heritage artefacts being uncovered from the foundation excavations is low. However, the area is relatively undisturbed, and any construction close to the dry stream bed must be monitored by the construction manager.

Final Decision

SAHRA Archaeology, Palaeontology and Meteorites (APM) Unit grants this application an exemption from further heritage assessments in terms of section 38(2)b of the National Heritage Resources Act, no 25 of 1999 (NHRA).

SAHRA has no objections to this proposed development going ahead and this Final Decision applies to the provisions of the NHRA only.
