A Heritage Impact Assessment report by Cultural Resources Consultants cc has been submitted to SAHRA in terms of section 38(1) of the National Heritage Resources Act, no. 25 of 1999 (NHRA). They have been appointed by the owner of the property of erf 650 (33 Devenish Street) in Polokwane City, Polokwane Local Municipality of the Limpopo Province. The Owner is requesting to demolish the Bauhaus styled historical house to make way for a new development. The house is over 60 years old and is protected in terms of section 34 of the NHRA.
