## **Final Comment**

The SAHRA Archaeology, Palaeontology and Meteorites (APM) accepts the HIA report and the recommendations contained in the report. The SAHRA has no objection to the development going ahead on the following conditions:

A Chance Finds Fossil Procedures must be developed by a palaeontologist and it must be included in the EMPr.

An archaeologist must be appointed to undertake monitoring of the area around site RS 1 during vegetation clearance. A report on the monitoring must be submitted to the case.

In the event that fossils are uncovered during construction then construction must cease within the immediate vicinity, a buffer of 30 m must be established, and a palaeontologist called in to inspect the finds. The palaeontologist must obtain a section 35(4) permit in terms of NHRA and Chapter IV NHRA Regulations, before any fossils are collected.

If there are any new heritages resources are discovered during construction and operation phases of the proposed development, then a professional archaeologist or palaeontologist, depending on the nature of the finds, must be contracted as soon as possible to inspect the findings at the expense of the developer.

If the newly discovered heritage resources prove to be of archaeological or palaeontological significance, a Phase 2 rescue operation may be required at the expense of the developer. Mitigation will only be carried out after the archaeologist or palaeontologist obtains a permit in terms of section 35 of the NHRA (Act 25 of 1999). The Final BAR and its appendices must be submitted to the case and once a Record of Decision from the competent authority is issued, it must also be submitted to the case.
