The Heritage Screener notes that the initial field survey (Binneman 2011) identified various significant MSA and LSA lithic scatters that are mostly out of context owing to water runoff. Some rock engravings and a gong rock were also identified during the survey. The 2011 report recommended further survey of boulders around the areas where the turbines will be constructed for potential rock engravings.

The area is known for the occurrence of surface fossil outcrops from a previous palaeontological field survey that was undertaken and fossils collected by the PalaeoBio research team. The Heriatge Screener recommends a field assessment of the area by a palaeontologist once the wind turbine layout is finalised.
