Banzai Environmental (Pty) Ltd and PGS Heritage (Pty) Ltd were appointed to provide heritage specialist input as part of the EA process as required by section 24(4)b(iii) of NEMA and section 38(8) of the National Heritage Resources Act, Act 25 of 1999 (NHRA).

The proposed development area is underlain by Late Caenozoic superficial sediments which are generally of low sensitivity but locally are of high sensitivity. It is considered that the proposed development will not lead to detrimental impacts to palaeontological resources of the area. A Chance Finds Protocol is recommended and is provided in the report.

Fourie, W. 2020. Heritage Impact Assessment: The Proposed New Cultivation (Pivot) areas on Portion 2 of the Farm Taaiboschfontein 168, Douglas, Sol Plaatje Local Municipality, Frances Baard District Municipality, Northern Cape Province.

A total of five areas contained Stone Age lithics where changes to the landscape were noted such as borrow pits, deflated areas and pan with animal borrows. The lithics were coming from a rock calcrete layer below the sand that covers the landscape. These sites were noted to be of low significance. A Chance Finds Procedure is recommended and provided in the report.

In an Interim Comment issued on the 17/05/2021, SAHRA requested that the draft EIA with associated appendices be submitted before further comments could be issued. Since the issuing of the Interim Comment, the draft EIA with appendices has been submitted to the application (11/11/2021).

The draft EIA has included the results and recommendations of the heritage specialists.

Final Comment

The following comments are made as a requirement in terms of section 38(8) of the NHRA in the format provided in section 38(4) of the NHRA and must be included in the Final EIA and EMPr:

- 38(4)a The SAHRA Archaeology, Palaeontology and Meteorites (APM) Unit has no objections to the proposed development;
- 38(4)b The recommendations of the specialists are supported and must be adhered to. No further additional specific conditions are provided for the development;

- 38(4)c(ii) If unmarked human burials are uncovered, the SAHRA Burial Grounds and Graves (BGG)

 section 36(6) of the NHRA. Non-compliance with section of the NHRA is an offense in terms of section
 51(1)e of the NHRA and item 5 of the Schedule;
- 38(4)d See section 51(1) of the NHRA regarding offences;
