## Final Decision

**In terms of Section 38(2) of the National Heritage Resources Act (Act 25 of 1999)**

Attention: Ms RENDANI PHADAGI

**Eskom Holdings SOC Ltd, Limpopo Operating Unit (LOU) intends to construct the power line for the above-mentioned project. The power line will be more than 300m MV, which will T-off from the existing power line in pole number AMP36/39/12/13/3/6/2A (refer to the Span plan sheets and the Pegging Coordinates for more information) traversing on the farm Zoetmelksfontein 36 JS , in Elias Motsoaledi Local Municipality of Sekhukhune District Municipality of the Limpopo Province**

Eskom SOC Ltd, Limpopo Operating Unit (LOU) is proposing to construct a new power line on behalf of their applicant, to supplying electricity to various households in Slovo Village. According to the documents submitted to the case, the proposed new MV power line will be 163m and the LV power line will 1096m in length. The power line will be starting at Amandla/Philadelphia 22 kV feeder in Limpopo Province.

The photos provided to the case do not show any surface heritage features therefore, the potential impact on heritage resources is considered low. The construction of a 22 kV power line in a an established village will not change the character of the landscape. The likelihood of heritage artefacts being uncovered from the foundation excavations is low. However, the area is relatively undisturbed, and any construction close to the dry stream bed must be monitored by the construction manager.

### Final Decision

SAHRA Archaeology, Palaeontology and Meteorites (APM) Unit grants this application an exemption from further heritage assessments in terms of section 38(2)b of the National Heritage Resources Act, no 25 of 1999 (NHRA).

SAHRA has no objections to this proposed development going ahead and this Final Decision applies to the provisions of the NHRA only.

development, then a professional archaeologist or palaeontologist, depending on the nature of the finds, must be contracted as soon as possible to inspect the findings at the expense of the developer.

If the newly discovered heritage resources prove to be of archaeological or palaeontological significance, a Phase 2 rescue operation may be required at the expense of the developer. Mitigation will only be carried out after the archaeologist or palaeontologist obtains a permit in terms of section 35 of the NHRA (Act 25 of 1999). If any unmarked human burials are uncovered and the archaeologist called in to inspect the finds and/or the police find them to be heritage graves, then mitigation may be necessary and the SAHRA Burial Grounds and Graves (BGG) Unit must be contacted for processes to follow (Mimi Seetelo 072 802 1251).
