### **Final Comment**

In terms of Section 38 of the National Heritage Resources Act (Act 25 of 1999)

PROPOSED CONSTRUCTION AND OPERATION OF THE BATTERY ENERGY STORAGE SYSTEM (BESS) AND ASSOCIATED INFRASTRUCTURE FOR THE AUTHORISED DROOGFONTEIN 3 SOLAR PHOTOVOLTAIC (PV) ENERGY FACILITY, LOCATED NEAR KIMBERLEY IN THE SOL PLAATJE LOCAL MUNICIPALITY, FRANCIS BAARD DISTRICT MUNICIPALITY, IN THE NORTHERN CAPE PROVINCE OF SOUTH AFRICA.

Sivest Environmental has been appointed by South Africa Mainstream Droogfontein PV 3 (Pty) Ltd to conduct an Environmental Authorisation (EA) Application for the construction of a BESS and associated infrastructure within the authorised Droogfontein 3 Solar PV Energy Facility, near Kimberley, Northern Cape Province (Ref: 14/12/16/3/3/1/2259).

A Final Basic Assessment Report (BAR) has been submitted in terms of the National Environmental Management Act, 1998 (NEMA) and the 2017 NEMA EIA Regulations. The proposed development includes a new battery energy storage system (BESS) within the authorised layout. It must be noted that SAHRA was not provided the opportunity to provide comments during the Public review phase of the project and the EA has been granted for the proposed BESS development on the 05/05/2021.

Banzai Environmental (Pty) Ltd and PGS Heritage (Pty) Ltd were appointed to provide heritage specialist input as part of the EA process as required by section 24(4)b(iii) of NEMA, and in terms of section 38(3) of the National Heritage Resources Act, Act 25 of 1999 (NHRA) as required by section 38(8) of the NHRA.

Butler, E. 2020. Palaeontological Desktop Report: Proposed Construction and Operation of the Battery Energy Storage System (BESS) and Associated Infrastructure for the Authorised Droogfontein 3 Solar Photovoltaic (PV) Energy Facility.

The proposed development area is underlain by the unfossiliferous Allanridge Formation and the Late Caenozoic superficial sediments which may contain fossils such as terrestrial plants and animals similar to modern day forms, as well as trace fossils, horn corns, teeth, tortoise amphibian and bivalves. A Chance Finds Protocol is recommended to be implemented.

Fourie, W. 2020. Heritage Impact Assessment: Proposed Construction and Operation of the Battery Energy Storage System (BESS) and Associated Infrastructure for the Authorised Droogfontein 3 Solar Photovoltaic (PV) Energy Facility.

No heritage resources were identified within the proposed development area. Recommendations include the need to implement a Chance Finds Procedure.

#### **Final Comment**

It must be noted that the EA application process has been concluded without including SAHRA during the review period. However, as no heritage resources were identified during the heritage assessments, SAHRA is satisfied with the submitted heritage reports. SAHRA will not follow appeal procedures for the granting of the EA without fully complying with section 38(8) of the NHRA i.e. including the comments of the relevant heritage resources authority during the decision making phase.

Furthermore, SAHRA notes Condition 35 of the granted EA and requests the applicant to make note of the following:

- If any evidence of archaeological sites or remains (e.g. remnants of stone-made structures, indigenous ceramics, bones, stone artefacts, ostrich eggshell fragments, charcoal and ash concentrations), fossils or other categories of heritage resources are found during the proposed development, SAHRA APM Unit (Natasha Higgitt/Phillip Hine 021 462 5402) must be alerted as per section 35(3) of the NHRA. Non-compliance with section of the NHRA is an offense in terms of section 51(1)e of the NHRA and item 5 of the Schedule;
- If unmarked human burials are uncovered, the SAHRA Burial Grounds and Graves (BGG) Unit (Thingahangwi Tshivhase/Mimi Seetelo 012 320 8490), must be alerted immediately as per section 36(6) of the NHRA. Non-compliance with section of the NHRA is an offense in terms of section 51(1)e of the NHRA and item 5 of the Schedule;
- See section 51(1) of the NHRA for a list of offences;
- The following conditions apply with regards to the appointment of specialists:
- If heritage resources are uncovered during the course of the development, a professional archaeologist
  or palaeontologist, depending on the nature of the finds, must be contracted as soon as possible to
  inspect the heritage resource. If the newly discovered heritage resources prove to be of archaeological
  or palaeontological significance, a Phase 2 rescue operation may be required subject to permits issued
  by SAHRA.
