The author undertook a field assessment of the proposed development area and identified a stone walled settlement in the north east section of the proposed development. This site maybe a cattle enclosure supporting the theory that it was a Later Iron Aged cattle outpost, may be associated with Ndebele type 2 settlements that are located close to the site. The site is degraded but the stonewalling is clearly visible. The author assessed the settlement to be of medium significance and recommends that this section is excluded from the development and a heritage management plan is created for the long term conservation of the site. The area is also ecologically sensitive and the ecologist recommended the area to be excluded from the

The SAHRA Archaeology, Palaeontology, and Meteorites (APM) Unit notes and accepts the submission of the draft BAR and HIA report, and accepts the recommendations provided by the Heritage Specialist. Furthermore, we grant the development from undertaking an assessment of impacts to palaeontological resources. SAHRA has no objections to the proposed development on the following conditions:

A Chance Finds Fossil Procedures must be developed by a palaeontologist and it must be included in the EMPr.

In the event that fossils are uncovered during construction then construction must cease within the immediate vicinity, a buffer of 30 m must be established, and a palaeontologist called in to inspect the finds. The palaeontologist must obtain a section 35(4) permit in terms of NHRA and Chapter IV NHRA Regulations, before any fossils are collected.

If there are any new heritages resources are discovered during construction and operation phases of the proposed development, then a professional archaeologist or palaeontologist, depending on the nature of the finds, must be contracted as soon as possible to inspect the findings at the expense of the developer.

If the newly discovered heritage resources prove to be of archaeological or palaeontological significance, a Phase 2 rescue operation may be required at the expense of the developer. Mitigation will only be carried out after the archaeologist or palaeontologist obtains a permit in terms of section 35 of the NHRA (Act 25 of 1999). If any unmarked human burials are uncovered and the archaeologist called in to inspect the finds and/or the police find them to be heritage graves, then mitigation may be necessary and the SAHRA Burial Grounds and Graves (BGG) Unit must be contacted for processes to follow (Thingahangwi Tshivase/Mimi Seetelo 012 320 8490).
