uKhozi Environmentalists (Pty) Ltd was appointed by Menar Capital (Pty) Ltd to conduct an Environmental Authorisation (EA) Application for proposed prospecting activities on various portions of the farms Gnoolooma 416, Melton 420, Diepwater 361, La Rochelle 359 and Plumstead 418, Kathu Magisterial District, Northern Cape Province (NC 30/5/1/1/2/12769 PR).

In a Final Comment issued on the 27/09/2021, SAHRA noted no objections to the proposed prospecting and provided conditions for the development (https://sahris.sahra.org.za/node/580875). Since the issuing of the Final Comment, a geological desktop was undertaken by a qualified geologist, which indicted the very low potential of manganese and iron on the properties applied for.
