Final Decision

Eskom Holdings SOC Ltd, Limpopo Operating Unit (LOU) hereby notifying you that it intends to construct the powerline for the above-mentioned project. There is an existing line in the farm, which will be dismantled, and construct a new power line that will be away from Mokolo River. The powerline will include new 1.537km MV that will be connected from pole number VB525/109/88/1 and will be supplying a customer in Dwaalhoek Farm 158 KQ in Modimolle Local Municipality of Waterberg District Municipality in the Limpopo Province

Eskom SOC Ltd, Limpopo Operating Unit (LOU) has submitted a section 38(1) of the National Heritage Resources Act, no 25 of 1999 (NHRA) application, on behalf of their applicant, to obtain a SAHRA decision in terms of section 38(2) of the NHRA for the construction of a new 1537m long power line starting at Vaalwater/Bulgerivier 22kV feeder. The power line will be supplying electricity to a gamer reserve overnight camp, along a gravel road on the remainder of the farm Dwaalhoek 158 KQ, in Lepelle Nkumpi Local Municipality of Limpopo Province.

The photos provided to the case do not show any surface heritage features therefore, the potential impact on heritage resources is considered low. The construction of a 22kV power line will not impact on heritage resources or change the character of the landscape. The likelihood of heritage artefacts being uncovered from the foundation excavations is low.

Final Decision

SAHRA Archaeology, Palaeontology and Meteorites (APM) Unit grants this application an exemption from further heritage assessments in terms of section 38(2)b of the National Heritage Resources Act, no 25 of 1999 (NHRA).

SAHRA has no objections to this proposed development going ahead and this Final Decision applies to the provisions of the NHRA only.
