Final Decision

In terms of Section 38(2) of the National Heritage Resources Act (Act 25 of 1999)

Attention: Mrs Galaletsang Mongalo Eskom MOU 28 Ferreira street Nelspruit 1200

Eskom Holdings, Mpumalanga Operating Unit is proposing to build a 1.557 km 11kV powerline from the SMY Moya feeder. The project will be within the Nyamazaan 647 JU property, Ehlanzeni District municipality, Mbombela Local Municipality, Mpumalanga province. The project will involve the digging of 2X2m and 2,4m deep holes to plant 14m wooden poles and install transformer to interconnect with another feeder.

Eskom Distribution SOC Ltd Limpopo-Mpumalanga Cluster (LIMLANGA) has submitted a section 38(1) of the National Heritage Resources Act, no 25 of 1999 (NHRA) application, on behalf of their applicant to obtain a SAHRA decision in terms of section 38(2) of the NHRA for the construction of a 1.557km power line, starting at the Simunye/Moya 11 kV feeder. The power line will provide electricity to the Kabokweni area, on the farm Nyamazaan 647 JU, Mbombela Local Municipality of Mpumalanga.

The photos provided to the case do not show any surface heritage features therefore, the potential impact on heritage resources is considered low. The construction of a 22 kV power line that is less than a kilometre in length will not change the character of the landscape. The likelihood of heritage artefacts being uncovered from the foundation excavations is low. However, the area is also located in a low palaeo-sensitivity area and the power line will have negligible impact on the palaeo-heritage.

Final Decision

The SAHRA Archaeology, Palaeontology and Meteorites (APM) Unit accepts application and all the supporting documents for this proposed power line route. Therefore, in terms of section 38(2)b of the National Heritage Resources Act, no 25 of 1999 (NHRA) the proposed development is granted an exemption from undertaking a Heritage Impact Assessment.

The SAHRA has no objections to this proposed development going ahead and this Final Decision applies to

the provisions of the NHRA only.

The following conditions still apply and need to be added to Appendix C 1.22:

If there are any new heritage resources discovered during construction and operation phases of the proposed development, then a professional archaeologist or palaeontologist, depending on the nature of the finds, must be contracted as soon as possible to inspect the findings at the expense of the developer.

If the newly discovered heritage resources prove to be of archaeological or palaeontological significance, a Phase 2 rescue operation may be required at the expense of the developer. Mitigation will only be carried out after the archaeologist or palaeontologist obtains a permit in terms of section 35 of the NHRA (Act 25 of 1999). If any unmarked human burials are uncovered and the archaeologist called in to inspect the finds and/or the police find them to be heritage graves, then mitigation may be necessary and the SAHRA Burial Grounds and Graves (BGG) Unit must be contacted for processes to follow (Mimi Seetelo 072 802 1251).
