Eskom Holdings, Limpopo-Mpumalanga Cluster(LIMLANGA) is proposing to build a 310m MV powerline from the Rooikrans 22kV feeder near Lydenburg. The project will be within the Rooikrans 57 JT property, Ehlanzeni District municipality, Thabachweu Local Municipality, Mpumalanga province. The project will involve the digging of 2X2m and 2,4m deep holes to plant 14m wooden poles and install transformer to supply a customer

Eskom SOC Ltd Limpopo Mpumalanga Cluster Operating Unit (LimLanga) has submitted a section 38(1) of the National Heritage Resources Act, no 25 of 1999 (NHRA) application, on behalf of their applicant to obtain a SAHRA decision in terms of section 38(2) of the NHRA for the construction of a power line, to provide electricity to an Eskom customer in the town of Lydenburg, Thaba Chweu Local Municipality of Mpumalanga.

The photos provided to the case do not show any surface heritage features therefore, the potential impact on heritage resources is considered low. The construction of a 22 kV power line that is less than a kilometre in length will not change the character of the landscape. The likelihood of heritage artefacts being uncovered from the foundation excavations is low. However, the area is also located in a low palaeo-sensitivity area and the power line will have negligible impact on the palaeo-heritage.

Final Decision

The SAHRA Archaeology, Palaeontology and Meteorites (APM) Unit accepts application and all the supporting documents for this proposed power line route. Therefore, in terms of section 38(2)b of the National Heritage Resources Act, no 25 of 1999 (NHRA) the proposed development is granted an exemption from undertaking a Heritage Impact Assessment.

The SAHRA has no objections to this proposed development going ahead and this Final Decision applies to the provisions of the NHRA only.
