The applicant, Studee Energy (Pty) Ltd is proposing to construct a new 10MW Solar PV power plant that is 20 ha in extent on PPC Dwaalboom property, on the farms Schoengezicht 238 KP and Jakhalskraal 239 KP, Thabazimbi Local Municipality of Limpopo Province. Construction will include a 1.9km 11kV power line from the facility to the adjacent cement factory,

The study area is located in a grey and green colour coded area on the SAHRIS palaeomap, according to the palaeomap policy, the area is of negligible and moderate significance.

A Heritage Impact Assessment (HIA) report has been submitted to SAHRA for commenting in terms of section 38 of the National Heritage Resources Act, no. 25 of 1999 (NHRA).

The study area is underlain by Vaalian aged dolomite rocks of the Malmani Subgroup, Chuniespoort Group, Transvaal Supergroup. It is also underlain by Vaalian aged shale, conglomerate, quartzite rocks of the Blackreef Formation of the Transvaal Supergroup, and a Quarternary aged black soils, red soils, ferricrete, conglomerate or breccia. Which is of moderate palaeontological sensitivity. Other portions of the development area are underlain by quartzite, arkose and conglomerate of the Venterdorp Supergoup. The potential impacts to palaeontological resources ranges from high to low. The author recommends that the ECO implements the chance finds procedure included under appendix 2 of the report.

Final Comment

The SAHRA Archaeology, Palaeontology and Meteorites (APM) accepts the HIA and PIA reports and the recommendations contained within the report. The SAHRA has no objection to the development going ahead on the following conditions:

A Chance Finds Fossil Procedures included under appendix 2 of the PIA report must be included in the EMPr.

In the unlikely event that fossils are uncovered during construction then construction must cease within the immediate vicinity, a buffer of 30 m must be established, and a palaeontologist called in to inspect the finds. The palaeontologist must obtain a section 35(4) permit in terms of NHRA and Chapter IV NHRA Regulations, before any fossils are collected.

If there are any new heritages resources are discovered during construction and operation phases of the proposed development, then a professional archaeologist or palaeontologist, depending on the nature of the finds, must be contracted as soon as possible to inspect the findings at the expense of the developer.

If the newly discovered heritage resources prove to be of archaeological or palaeontological significance, a Phase 2 rescue operation may be required at the expense of the developer. Mitigation will only be carried out after the archaeologist or palaeontologist obtains a permit in terms of section 35 of the NHRA (Act 25 of 1999).
